#### 1. FROM NATA : CHANGES ARE BEING MADE TO WEBSITE

In order to provide a more streamlined, user-focused web experience on the NATA website, the NATA membership database is being moved to a new platform on the back-end Sept. 19. This means a few changes to the website will occur soon. NATA members will be required to do a Password Reset everyone who has created a user profile on nata.org should have received an email Sept. 19 requesting their password be reset. The R&G committee enjoyed a quiet summer after a year filled with action and are gearing up for what we anticipate will be another great year.



I will be joining a conference call with the chair of the NATA Foundation Free Communications committee this month with the rest of the district R&G chairs. We will get to share information about the successes of our programs and also get the latest updates on things happening on the national level so we can best help our district members be successful in securing grants and having Free Communications abstracts accepted for presentation at the NATA convention.

Since the FWATA Annual Meeting is in July this year, we will be pushing our review deadlines back a bit to give everyone more time to get some data sets completed. (I'm looking at you, masters' thesis folks!) The call will go out at the end of the year so stay tuned!



### College and University Athletic Trainers Committee Brian Cable ATC

A survey was conducted by the National Athletic Trainers' Association's (NATA) Intercollegiate Council for Sports Medicine (ICSM). The results were presented at a press briefing during the NATA's 70th Clinical Symposia in Las Vegas. The results looked at how well institutions performed in their administrative structure to ensure the institutional line of medical authority is established according to NCAA's Independent Medical Care for College Student-Athletes inter-association consensus statement. The results of the survey are found here (https://www.nata.org/press-release/062619/only-half-

collegiate-level-sports-programs-follow-medical-model-care-student).

The NCAA's Independent Medical Care for College Student-Athletes inter-association consensus statement desires that an Institutional line of medical authority should be established in the sole interest of student-athlete health and safety and that the health care providers should have unchallengeable autonomous authority in return to play decisions. The statement is found here (http://www.ncaa.org/sport-science-institute/athletics-health-care-administration-best-practices-0).

The ICSM followed up this press release with a meeting in August in Dallas, Tx. The goal of the ICSM is to have a document to give to the membership and institutions on how to ensure medical autonomy is in place at each institution.

FWATA CUAT is also supporting a data collection pilot program between the NJCAA and CCCATA. We hope to get volunteers from schools (2 NorCal, 2 SoCal) using software (CSMI or ATS) to take part in injury and treatment tracking. The collection will be automated and load directly from existing software. This data will be compiled and hopefully allow us to expand to additional colleges in the future. ### California Update Jason Bennett DA, ATC | CATA President

I am pleased to report one of the legislative bills we supported was recently signed by the governor. AB-379 (Maienschein) required the addition of "an athlete who has passed out or fainted" to existing law for youth sport organizations and prohibits an athlete from returning to athletic activity until being evaluated and cleared by a health care provider. Requires the athlete, if the health care provider suspects that the athlete has a cardiac condition that puts the athlete at risk for sudden cardiac arrest (SCA) or other heart-related issues, to remain under the care of the healthcare provider to pursue follow-up testing until the athlete is cleared to play.

The bill also requires "sudden cardiac arrest prevention" as part of coach and administrator education requirements.

The CATA invites athletic trainers and athletic training students to attend the Annual Symposium and Hit-the-Hill event on February 22-24, 2020 in Sacramento. Our Hit-the-Hill event will be extremely important as we continue to support AB-1592 (Bonta) and our push for licensure for athletic trainers in our state. The symposium will return to the Embassy Suites again where the triple-room occupancy, full breakfast, and free happy hour drinks have been well received in the past. Registration for the conference will open in November on the CATA website. While FWATA's Annual Conference is in Hawaii in July and the NATA Annual Clinical Symposia is in Atlanta in June, we hope to have our best turnout ever in Sacramento while earning CEUs and supporting AB-1592. If you haven't sent in your letter of support for AB-1592, please go to our website at ca-at.org and submit your letter – it takes only about 30 seconds to have a positive impact on our future.

I would like to express my gratitude to Ken Look for his work over the last three years as our Revenue Chair. Under Ken's leadership we have been able to expand our sponsorships at our Annual Symposium and our website and increase our visibility amongst potential vendors. If there are any members that would are interested in the Revenue Chair position, please send a letter of interest and resume to our CATA Secretary, Christina Scherr, at cscherratc@gmail.com to be considered. Also, congratulations to Matt Quijano for being elected as our newest Region-4 Director beginning on January 1st.

Finally, the CATA also encourages nominations for all of our state-level awards. Awards available include the State Recognition Award, Educator Award, Lifesaver Awards, and our newest award – the Athletic Trainer of the Year award. If you know someone who goes above and beyond, please nominate them to be recognized. Aloha from the Islands! The Hawaii Athletic Trainers' Association (HATA) continues to press forward with multiple CEU opportunities for the membership. High School AT's partnered with the Hawaii Concussion Management Program (HCAMP) to review the updated spine boarding protocol at Aloha Stadium. HCAMP also sponsored the annual Concussion Summit, leading to a maximum of 8.5 Cat. A CEU's and 3 EBP's.

HATA also partnered with Hawaii Pacific Health for their annual Sports Medicine Symposium, that featured Adolescent elbow and shoulder injuries and Signs and Symptoms of adolescent depression and screening tools that can be utilized. 4 Category A CEU's were offered for this event.

HATA's annual symposium had a unique approach this year. The May 30th event was held at the John Burns School of Medicine and involved Scapular Dysfunction in addition to a Scapular and Upper Extremity lab. Kamehameha Schools hosted the 2nd day of the symposium, which included EBP lectures for the Overhead Athlete and a Rehab to Performance section using the ARP Wave electrotherapy device. Attendees were awarded 3.5 EBP's and 7.5 Category A CEU's.

Lastly, HATA held our annual golf tournament on May 31st to benefit our Scholarship Fund. It was a beautiful day in Central Oahu where we had 150 golfers, 25 volunteers and tons of fun at Mililani Golf Course. We will be back at Mililani GC on May 29, 2020, so make your plans to join us!!!

#### Dry Needling addition to NRS 640B scope of practice for athletic trainers:

During the 80th Session of Nevada State Legislature, Senate Bill 186 was introduced to expand the scope of Nevada's athletic training practice act, NRS 640B, to include the practice of dry needling under specific regulations. It subsequently passed in during the session, was approved by Governor Steve Sisolak on June 1st, 2019 and is set to go into effect on October 1st 2019. Currently, the Nevada State Board of Athletic Trainers' is creating regulations and language fitting for this new provision. Updates to the bill can be reviewed by searching for LCB File No. R053-19. Thank you to the Nevada State Board of Athletic Trainers' for all of your hard work on this!!

**Constitution restructuring:** One of the biggest undertakings of the year for the Nevada Athletic Trainers' Association has been the re-writing and restructuring of our organization's constitution and bylaws. During the spring, the board created the Constitution Committee composed of Dustin Hopfe (Committee Chair), Steve McCauley, David Orr, and Christine Wittorff. They stripped down our constitution to propose changes in term lengths, promote better top down organization, and to create consistency with our governing body that mirrors other state, regional, and national levels. This effort will allow for more streamlined communication, improved establishment of committees, and will hopefully encourage more individuals to volunteer within their desired areas of interest. We will be voting on these proposed changes during the NEVATA State Meeting and Clinical Symposium in October.
